**COMPETITION NOTICE FOR THE AWARDING OF A PRIZE FOR A DOCTORATE THESIS IN
NUTRACEUTICALS, FUNCTIONAL FOODS AND HUMAN HEALTH ENTITLED
“MEDWELL (Mediterranean Wellbeing for Human and the Environment),
dedicated to the memory of Prof. Alberto Ritieni”**

ARTICLE 1

The Department of Pharmacy of the University of Naples “Federico II”, on the initiative and with funds made available by the benefit company ALSA LAB SRL, announces a competition for the awarding of a Prize for a Doctorate Thesis in Nutraceuticals, Functional Foods and Human Health entitled “MEDWELL (Mediterranean Wellbeing for Human and the Environment), dedicated to the memory of Prof. Alberto Ritieni”, for the amount of € 5,000.00

ARTICLE 2

The competition aims to reward the best research project related to health and nutraceutical aspects among those conducted during the XXXVII Cycle of the International Doctorate in Research in Nutraceuticals, Functional Foods and Human Health and doctoral research projects carried out in the same scientific topic by doctoral students from universities in European countries in the Mediterranean region.

ARTICLE 3

The competition is reserved for those who have obtained the title of Doctor of Research in the XXXVII Cycle of the Doctorate in Research in Nutraceuticals, Functional Foods and Human Health at the University of Naples Federico II and to those who have obtained the title, in the same scientific topic, in doctoral courses carried out at universities in European countries in the Mediterranean region, as indicated in Article 2 of this announcement, from January 1st 2025 to August 31st 2025, discussing a thesis on research topics related to nutraceuticals, supplements or functional foods, with particular interest in the formulation and analytical aspects related to these topics.

ARTICLE 4

The selection of candidates will be carried out by an examination commission based on the evaluation of PhD theses.

The judgment of the commission is final.

The commission will not award the Prize if the theses presented are not sufficiently meritorious.

ARTICLE 5

The Commission is composed of:

- Director of the Department of Pharmacy (or his/her delegate)
- Coordinator of the PhD in Nutraceuticals, Functional Foods, and Human Health (or his/her delegate)
- Two members designated by the Coordinator of the PhD in Nutraceuticals, Functional Foods, and Human Health
- Legal representative of ALSA LAB SRL (or his/her delegate)

ARTICLE 6

The Award will be conferred by Decree of the Director of the Department of Pharmacy and paid in a single solution.

ARTICLE 7

Under penalty of exclusion, applications to participate in the selection, duly signed and accompanied by the attachments indicated below, must be sent, via an Internet file transfer service (e.g. WeTransfer), from the candidate's personal email address, to the Department of Pharmacy, at the email address: dip.farmacia@unina.it starting from 00.01 on September, 1, 2025 and no later than 23.59 on September, 25, 2025 and must have the subject: "Prize for PhD thesis in Nutraceuticals, Functional Foods and Human Health".

Always under penalty of exclusion, in the application for participation, to be prepared according to the attached form, which is an integral part of this announcement, the candidate must declare, under his/her own responsibility:

- 1) his/her personal details (surname, name, date and place of birth, tax code, residence, and e-mail address to which he/she wishes communications relating to the selection to be made, telephone number).
- 2) that he/she meets the conditions set out in the announcement, specifying that he/she has obtained the qualification required by this announcement at the University of Naples "Federico II", or at the Universities present in the European countries included in the Mediterranean region as indicated in Article 2 of this announcement, with the indication of the title of the PhD thesis in relation to the topics referred to in Article 3 of the announcement, of the final assessment, in which it was obtained.

The application must be accompanied, under penalty of exclusion:

- a copy of the candidate's valid identification document.
- a copy of the document certifying the achievement of the Doctoral Degree.
- a copy of the Doctoral thesis in PDF format.
