

CALL FOR APPLICATION FOR THE PARTICIPATION TO “ERASMUS+ BLENDED INTENSIVE PROGRAM” (BIP) at the Faculty of Albacete, Universidad de Castilla La Mancha, in *Drug Discovery and Development*.

The call for applications is hereby published for the participation to “Erasmus+ Blended Intensive Program (BIP) entitled “*Drug Discovery and Development*” that will be held in blended mode as follows:

- **Online lectures** (07.07.2025), 6 lectures
- **In presence** at the Universidad de Castilla La Mancha, Faculty of Albacete (5 days) from July 1 to 4 (attached the full program).

BIPs are short-term Intensive Study Programs, which include in-person and online attendance and in person and online lessons. This program will focus on the pathway to go from plant collection to their use in phytotherapy.

The call, having deadline on 28/05/2025 is addressed to students from the University of Naples Federico II who, at the moment of the application, are regularly enrolled in Doctoral Programs of the Department of Pharmacy or Degree programmes, a.y. 2025/2026 in Pharmacy, CTF or Herbal Sciences and Technologies.

All the activities will be hold exclusively in English, thus knowledge of English language is required and will be verified during the interview.

The students that will successfully complete the programme (virtual and physical mobility – both mandatory – and a final project discussed with an oral exam) will receive 3 ECTS.

ADMISSION REQUIREMENTS

The Selection Committee will select 5 students as Erasmus Students (the Erasmus program will award the 5 students with a scholarship covering travel and lodging expenses

Applicants should be regularly enrolled for the a.y. 2025/26.

APPLICATION PROCEDURE

Applicants will send their candidature sending all the documents by e-mail to: carmen.digiovanni@unina.it by the deadline 28/05/2025.

- Curriculum Vitae
- Certificato Storico by Segrepass
- Motivational letter in English (max 300 words), all 3 documents in a zip file.

The selection is the sole responsibility of the departments DIPFARM of the University of Napoli Federico II and consists in both title’s evaluation and oral interview.

CRITERIA FOR THE FORMULATION OF THE RANKING

The Commission will assign the score as follows:

- Max. 10 points for the evaluation of the academic career.
- Max. 15 points for the motivational letter and CV.
- Max. 15 points for the oral interview.
- Max. 5 points for English language knowledge.

In case of incomplete documentation, the application will be rejected.

PUBLICATION OF RANKINGS

Rankings and information about the oral interview will be published on the Department's website by May 31, 2024.

FINANCIAL CONTRIBUTION

According to Erasmus+ Programme, the financial contribution is established as follows:

Duration of in-person mobility: until the 14th day of activity 79 euro/day

A one-time-only extra amount of 100€ to the individual support of the EU contribution for an in-person mobility from 5 to 14 days, or 150€ for an in-person mobility from 15 to 30 days, is also available for students with fewer opportunities, with ISEE < €15,000 used for university purposes as submitted by the Erasmus grant winners for their latest enrolling.

Students that will choose a "green" travel solution will receive another extra amount of 50€ one-time only. Further information about the financial contribution will be provided to the students that will be selected for this programme.

Erasmus+ contributions are related to the activities abroad and to the recognition of such activities by the University. Students that will not complete all the steps will have to return the whole amount of the contribution.

DATA PROCESSING

Information on the processing of personal data pursuant to art. 13 of Regulation (EU) 679/2016 laying down rules on the processing of personal data and the code regarding the protection of personal data, Legislative Decree No. 196/2003 supplemented and amended by Legislative Decree No. 101/2018.

PURPOSES AND MEANS OF PROCESSING.

The personal data provided during the application for participation or acquired subsequently during the relationship with the University will be processed for institutional purposes, for administrative and accounting obligations related to the agreement.

To this end, personal data such as name, surname, residence, personal data, tax code, contact details, address, email, data relating to the qualifications held to the school career may be collected.

MANDATORY PROVISION OF DATA AND CONSEQUENCES OF ANY REFUSAL.

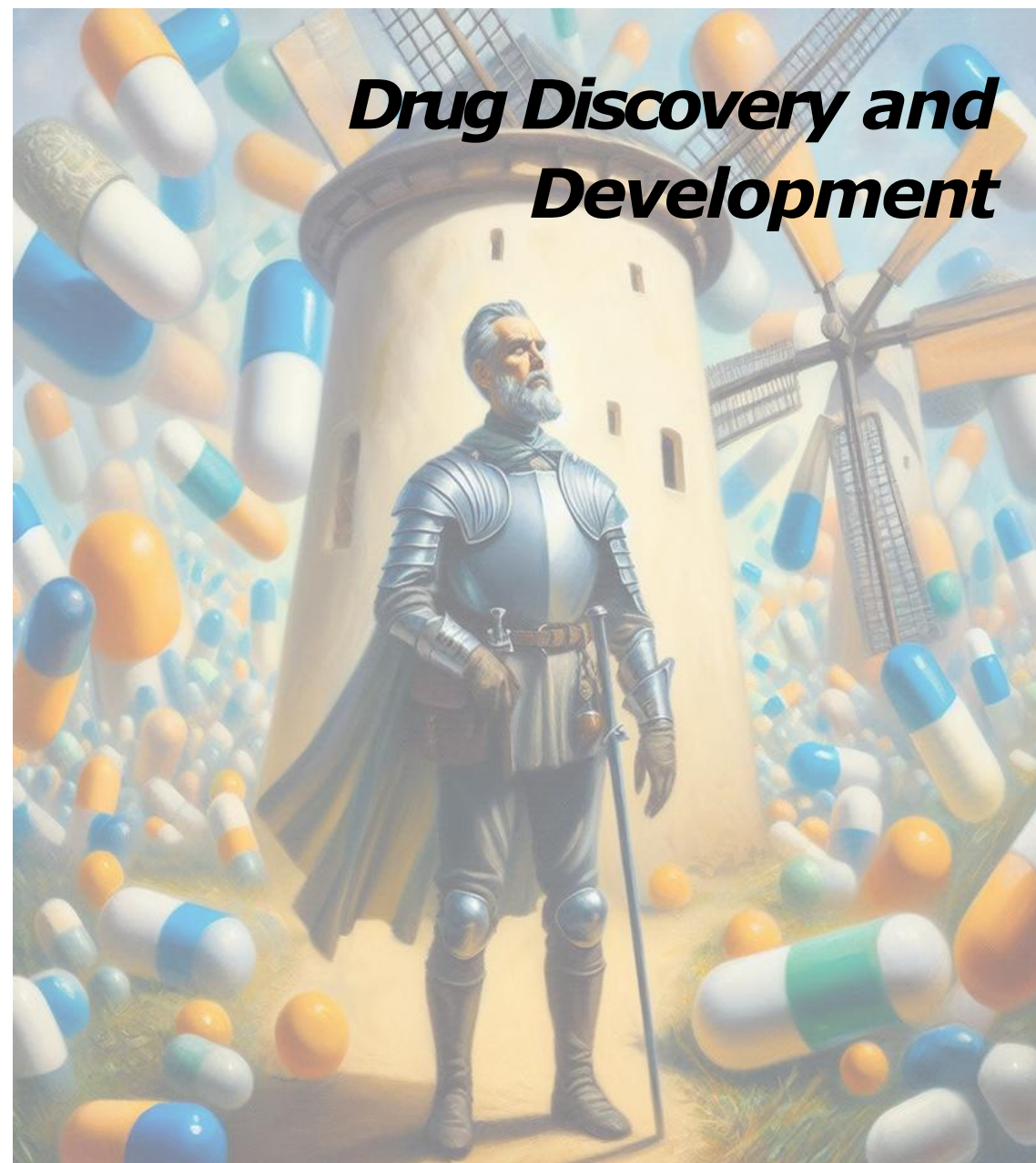
The processing of personal data is mandatory for the purpose of assessing the requirements for participation in the aforementioned call.

For these reasons, consent to the processing of data is not required. Any refusal will make it impossible for the University to fulfill these purposes and participation in the program.

COMMUNICATION AND DISSEMINATION OF DATA: Personal data will be processed for the performance of institutional activities according to the principles of lawfulness, necessity, non-excess, relevance and correctness, in accordance with European and national legislation and the University Regulations on the subject; the data may be disclosed in particular to the following subjects (Erasmus+ National Agency -INDIRE; European Commission, Ministry of Education, University and Research; University; Host company; Affiliated banking institution).

In compliance with the provisions on Transparent Administration (Legislative Decree No. 33/2013 and subsequent amendments) personal data, except for the particular categories – referred to in articles 9 and 10 of the EU Regulation – are disseminated through publication on the university's institutional website for the period provided for by law.

RIGHTS OF THE INTERESTED PARTY: At any time, the student may exercise his rights pursuant to articles 15-22 and 77 of the EU Regulation, where the conditions are met.
